
# **Summary of 5,602 Persons**

Stating Concerns About Wakesurfing July, 2020 - March, 2022

**Prepared by Citizens For Sharing Lake Minnetonka** 

5,602 comments (posts + likes of posts on social media sites) that expressed dissatisfaction with wakesurf boats are tabulated and presented in this document for the period July, 2020 - March 2022. Interference with the enjoyment of other recreational activities was the greatest concern expressed, followed by environmental concerns and loud music.

Not just a Lake Minnetonka issue and not just a Minnesota issue. Comments on this article are echoed across the U.S., Canada, Australia and New Zealand. Simply put, every element of the design of a wake boat is with the goal of creating a massive wake to facilitate wake surfing. When operated in shallow water (less than 16'), the powerful downward thrust of the 400+ hp propulsion system while plowing through the water at 9-10 mph causes environmental damage at the lake bottom. The wake energy created by these boats is exponentially greater than wakes from any other recreational sport boat. These wakes do erode shorelines, and damage lifts, docks and moored watercraft. They also cause safety issues with other lake users, whether on the lake or at the shore. If operated in a lake that has Aquatic Invasive Species, these boats carry the highest risk of transporting AIS because their ballast systems cannot be completely emptied. While some studies have been done, I'm encouraged that a valid scientific study is going to be done in Minnesota. There are several Minnesota lakes of less than 240 acres with 15 to 30 of these boats resident on the lake and these lakes also have public accesses. On a small lake, it only takes one of these boats to cause the concerns noted. The

"Wake Responsibly" campaign by the Boating Industry says (1)Stay at least 200' from shore, (2)Try to keep your music down, and (3) Try not to make repetitive passes. This campaign has been around since 2017 and yet the concerns are growing. These boats are being operated as designed and "Education" based on the Boating Industry's suggestions will do virtually nothing to address the valid concerns people have shared. This isn't a "Not on My Lake" issue. It is an issue that all Minnesotans should be concerned about. ???

TWICE last season, we were tied up with friends in a no-wake zone in Maxwell Bay and some wakeboaters came so close that the waves caused our boats to smack up against each other so hard that it snapped a quarter-inch line! Then you get the d-bags that insist on circling you way too close, going round and round and round ad nausea like some kind of sick horror movie. It happens all the time in Harrisons Bay, Maxwell Bay, etc. I have no problem with wake boarding per se, but some of them are complete pricks and they ruin it for the ones that do it right. And, doing it right is not hard: just stay away from shorelines and anchored boats, and don't circle the same bay multiple times. It's really not that hard.

The fact is it IS a problem, whether you want to admit it or not. Shore erosion is real. Big wakes DO do damage. Some wakeboats are only 18-20 feet long yet they put out wakes bigger than 40 foot boats, and 40-footers don't go round and round in the same bay 100 times a day. Painting it as a "liberal" issue

or a "difference of opinion" or "fun killing" just shows that you're incapable (or unwilling) of understanding science or discerning nuance -- not everything is black and white. It's easy for many people to say "it's no big deal" when they DON'T live in the lake and have property that gets damaged. Yes, wakeboating is fun. Yes, plenty of wakeboaters do it right. But, many of them don't, and they are fu\*\*ing up the lake, and it's reaching a boiling point.

If you're against this, know this: you're in a vocal minority. The majority of those who live on and use the lake regularly are not in your corner. Either be part of the solution or don't. But, make no mistake, there WILL be legislation on this, so why not get in front of the issue before it's too late? We can all co-exist, but it starts with wakeboaters admitting that, yes, it IS an issue. Ignoring it will get you nowhere. Reaction to Post: Like 10

Seems other states are also addressing wake boats and the potential of causing problems. As more and more people buy and use these wake boats, so too, will the laws come that could eventually ban their use for creating wakes. In New Hampshire, concerns are serious enough that the Legislature has formed a study committee to evaluate the watercraft's impact. In Chesapeake Bay, they have enough evidence to suggest an impact of boat wakes, protective policy measures should be adopted in highly vulnerable systems to reduce current boat wake energy. In Michigan and their inland lakes, 1. Reduce their speed within 500 feet of shore; 2. Not add ballast water or other extra weight to their boats; 3. Not operate their boats near sandy areas, wetlands or lakefront residences; 4. Avoid turning their boats in tight circles (tight circles increase wave height and frequency); 5. Avoid operating their wake boats in shallow water or near natural shorelines. Some states such as Missouri have passed new laws that can hold the boat owner responsible for wake damage or injuries if the operator can't be identified. Other municipalities have gone so far as to pass ordinances that prohibit "artificially enhanced wake" on local waterways. On August 29th 2020 we decided to take a boat ride to Excelsior from our home on Casco Point. We set out for lunch in our 23' Kayot Deck Boat. We had a delightful ride over to Excelsior and found a place to dock at the city tie up. We enjoyed a lunch outside at Red Bench Bakery, wandered about town in our masks for awhile and went back to our boat. I noticed as we pulled our that the wind had gotten stronger and we were rocking more from the waves. We had just started our journey back home when I noted two wake boats, one on either side of us throwing up huge waves. As the waves got closer I could see that they were 4-5 feet high. I turned the boat to cross the first wave and that is when my wife, Michelle, literally flew up in the air and came down on her tailbone. She screamed and laid flat on the seat and continued screaming. I was standing and took the action from the wave with my knees bent and holding onto the steering wheel.

Michelle continued to scream and begged me to go as slow as possible. It was a very difficult time getting back to our dock. She was in such great pain and I felt helpless. After an hour and a half we were as our dock. I called 911 and requested an ambulance. The first responders were two Orono police officers, then the ambulance came, then the Sheriffs deputies pulled up to our dock. Michelle was placed on a backboard after she had an IV started for pain. Then the ordeal of getting her off the boat took all six of the responders. I am 76 years old and stayed out of the way. She was placed in the ambulance at take to Park Nicollet Orthopedic Center in St Louis. I was not allowed to go. I did not see Michelle for 5 days. I picked her up at the hospital and she came out wearing a neck to hip wraparound back brace. We were then housebound for 10 weeks or rest with me taking over all of the household chores. We came home to Indiana on 8 November.

Hi, I am Dan Adams and I have lived on North Arm Bay since 1991. I have had many years of enjoyment on the bay but the last few years have seen many changes, most notably the rise in the number of people and boats using the bay for wake board surfing. I have seen up to 5 boats attempting to wave surf at the same time. I have a rip-rap shore line and the waves from these boats have caused a couple of large boulders to fall from the shore line. I had to hire a barge to place them back along the shore. At times the house shakes from the loud music (rap) playing from these boats when their speakers are pointed at the house. I have been known to be so irritated that I would shout out to the boats to turn the music down. The boat in the slip tosses around with every wave and I can see the irritation from people trying to fish or navigate small boats, canoes, paddle boards, and kayaks. Docks with wooded decks in high water can have their decking raised to the point that sections can float away from the large waves from Wake Surfing Boats. The waves seem to get bigger each year. If I wanted to sell wake boats I would design them to offer the highest waves in the industry to sell more boats. Unfortunately this is what is happening due to competition. I haven't seen as many Loons on our bay that a saw a few years ago. Perhaps they are also irritated by the noise and waves. I don't blame them if they have moved on to quieter water. I can say that I do not enjoy the lake as much as I used to. Last year, someone started water skiing on our bay in the morning and I noticed how small the waves were in comparison to wake board surfacing, and without music blasting and I was hoping maybe that would catch on but I can't confirm that it has yet.
